OFFICIAL CONTEST RULES & REGULATIONS "2024 North Central Co-op Fuel Your Summer Giveaway"

"2024 North Central Co-op Fuel Your Summer Giveaway" (the "Contest") is sponsored by North Central Co-operative Association (the "Sponsor"). The Contest runs 8:00 am MST May 2nd, 2024 (the "Contest Start Date") and ends 11:59 pm MST July 24th, 2024 (the "Contest Closing Date"), known as the "Contest Period". The Contest is being promoted at North Central Co-op Gas Bar sites throughout the Edmonton Capital Region – ("Participating Stores").

1. HOW TO ENTER:

NO PURCHASE NECESSARY.

Method #1

- a. Share the YEGWAVE x North Central Co-op Giveaway Instagram Post on their social profile story, while tagging three friends they'd take to the Elks Game, NCC, YEGWAVE, and following NCC & YEGWAVE for a single entry.

Method #2

- a. Between May 2nd and July 24th, spend at least \$40 CAD on fuel from any North Central Co-op Gas Bar.
- b. Upload the receipt on our contest page and spin the digital wheel for a chance to receive up to 50 bonus entries per qualifying receipt of at least \$40 CAD.

All entries must be received before the Contest Closing Date to be entered into the Contest. Limited one entry per visit.

2. ELIGIBILITY:

Eligible

To enter the Contest and be eligible to win a prize in the Contest, a person must be a resident of Alberta and be the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

Not Eligible

Residents outside of Alberta are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of Participating Stores, the Participating Stores' Boards of Directors as well as the immediate family* and those domiciled with the Participating Stores' employees and the Participating Stores' Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Participating Stores' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

* "Immediate family" means members living in the same household.

the event that a prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize of equal or greater value without liability.

4. PRIZE WINNER:

Five (5) winners will be randomly selected as follows. One (1) fuel gift card winner on May 23rd, one (1) fuel gift card winner on June 13th, one (1) fuel gift card winner on July 4th, and the final two (2) winners drawn from all valid entries after the contest closes on July 25th, 2024. The winners will be contacted shortly after they are drawn. If a selected entrant cannot be contacted within two day of the draw date his/her entry will be disqualified and another entrant will be selected. To be declared a prize winner (the "Prize Winner"), the selected entrant must: (1) correctly answer a mathematical skill testing question to be administered via telephone, mail or email; (2) show government identification to confirm identity; and (3) complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor within one day of receipt of written prize notification or prize will be forfeited and an alternate Prize Winner selected. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor or the Participating Stores.
